

## **LET'S GO SPORTS / HOOPS ACADEMY**

### **LIABILITY WAIVER, MEDICAL CONSENT & PHOTO RELEASE**

#### **1. ASSUMPTION OF RISK**

I acknowledge that participation in physical activities offered by **Let's Go Sports** and **Let's Go Sports – Hoops Academy** involves movement such as running, jumping, stretching, dribbling, throwing, and use of sports equipment.

I understand that such activities carry a risk of injury, including but not limited to scrapes, falls, sprains, collisions, and equipment-related injuries.

By signing this form, I voluntarily allow my child to participate and accept all risks involved.

#### **2. RELEASE OF LIABILITY**

In consideration of my child's participation, I hereby fully release, waive, discharge, and hold harmless:

- **Let's Go Sports**
- **Let's Go Sports – Hoops Academy**
- **All owners, coaches, employees, contractors, and volunteers**
- **Any daycare, center, school, or facility partnered with Let's Go Sports**
- **Their staff, directors, officers, and representatives**

from ANY and ALL liability, claims, demands, causes of action, or damages arising from participation in sports activities, whether occurring on the daycare premises, during instruction, before or after class, indoors or outdoors.

This includes, but is not limited to:

- Accidents
- Injuries
- Illness
- Property loss or damage
- Acts of other participants

- Weather-related or surface-related incidents
- Equipment use

This waiver applies regardless of negligence, except for cases of intentional misconduct.

### **3. MEDICAL CONSENT**

In the event of illness, injury, or emergency, I authorize **Let's Go Sports, Hoops Academy**, or daycare staff to secure medical treatment for my child.

I assume full responsibility for any medical expenses incurred.

### **4. PARENT/GUARDIAN RESPONSIBILITIES**

I confirm that:

- My child is physically able to participate in sports activities
  - I have disclosed all allergies, medical needs, or limitations
  - My child will not attend when sick
  - My child will wear proper athletic footwear
  - I understand behavior issues may result in removal without refund
- 

### **5. INDEMNIFICATION AGREEMENT**

I agree to indemnify and hold harmless:

- **Let's Go Sports – Hoops Academy**
- **Partnering daycare or facility**

from any claims brought by me, my child, or any third party resulting from participation in the program.

I understand I am giving up the right to sue the above entities for injuries or damages.
